PARCEL D

BEGINNING at mouth of Headforemost Creek where it empties into the Middle Saluda River and running thence with said creek to where it strikes the back line of said tracts; thence, with the old line on the Southwest corner to a point which equally divides a 40 acre tract into an upper and lower tracts; thence, in a straight line going south to a point on the Middle Saluda River; thence with said river to the beginning corner, less, however, and excepting nine screws, more or less, heretofore conveyed to Stansell, leaving a balance of acreage in parcels C & D of eighteen acres, more or less.
