WHEREAS, *we*, the said *M. D. Berry, J. B. Berry, J. F. Berry, W. E. Berry, Irene Tate and Pauline Emanuel*, in and by *our* certain promissory note in writing, of even date with these presents *are* well and truly indebted to THE PEOPLES BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *Twenty-Five hundred (\$2500.00)* DOLLARS,
