THIS INDENTURE, made this 27th day of November A. D. 1929  
by and between J. Saul

party of the first part, and the MECHANICS BUILDING AND LOAN ASSOCIATION, of Greenville, S. C., a corporation, party of the second part,

WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of Forty-two hundred no/100 Dollars, money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly,

the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

In Greenville Township, known and designated as lots nos. 1, 7, 9, 11, 13, 15 and 17 on plat of property of J. Saul made by R. E. Dalton, Engineer in August 1924 recorded in P. M. O. office for Greenville County in plat book 8 page 246 and having the following meters and bounds  
Lot no. 1: Beginning at an iron pin on the South-west corner of Wilbanks Street and White Horse Road and running thence with White Horse Road S. 11.40 N. 80.85 feet to iron pin, corner of lot no. 2; thence with line of said lot S. 78-50 N. 179.4 feet to iron pin in line of lot no. 3. thence with line of said lot N. 10-15 N. 75 feet to iron pin on Wilbanks Street, N. 79-45 E. 209.6 feet to the beginning  
Lots nos. 7, 9, 11, 13, 15 and 17 are described in the aggregate as follows: Beginning at an iron pin on the South side of Wilbanks Street 269.6 feet west of the White Horse Road and running thence with line of lot no. 3 S. 10-15 E. 150 feet to iron pin corner of lot no. 6; thence with line of lots 6, 8, 10, 12, 14 and 16, 360 feet to iron pin corner of lot no. 19; thence with line of said lot N. 10-15 N. 155.4 feet to iron pin on Wilbanks Street thence with said Street N. 79-45 E. 360 feet to the beginning.
