"All that piece, parcel or lot of land situate, lying and being in the County and State aforesaid, on the Anderson Road, just outside the corporate limits of the City of Greenville having the following metes and bounds, to-wit: Beginning at a stake on Anderson Road, corner of Lot No. 3, and running thence N. $50\frac{1}{2}$ W. 110 feet to a stake on line of Lot No. 6; thence S $56\frac{1}{4}$ W. 68 feet to a stake on Cobb line, thence along said line S $50\frac{1}{2}$ E. 110 feet to an iron stake on Anderson Road; thence along said road N. $56\frac{1}{4}$ E. 68 feet to the beginning corner, containing 6820 square feet, more or less, and bounded by the Anderson Road, Lots nos 3 and 6 and land of Cobb, the same being known and designated as Lot No. 4 of survey and division made by J. N. Southern, May 6, 1906. Same being conveyed to J. C. Martin by J. R. Martin by deed recorded in D.D., at Page 358, R. M. C. Office for Greenville County.
2. Also, All that piece, parcel or lot of land situate, lying and being in the County and State aforesaid, on the Anderson Road, just outside the corporate limits of the City of Greenville, having the following metes and bounds to-wit: Beginning at a stake on the South west corner of Sterling Street or Martin Street and Anderson Road and running thence with Anderson Road S $56\frac{1}{4}$ E. 68 feet to a point on the corner of Lot No. 4; thence S $50\frac{1}{2}$ W 110 feet along line of Lot No. 4 to point; thence N. $56\frac{1}{4}$ W. 68 feet to Martin Street; thence N. $50\frac{1}{2}$ W. 110 feet to Anderson Road and the beginning corner, being the same tract of land conveyed to Nattie Logan by J. R. Martin and to J. C. Martin by Nattie Logan Duckett. There being situate on the above described lots two (2) dwelling houses, these lots being situate just north on the Anderson Road from the Estate known as Martindale."

Also, All that piece, parcel and lot of land situate, lying and being at the corner of Green Avenue and Nichols Streets in the City and County of Greenville and State of South Carolina, and having the following metes and bounds, to-wit: Beginning at a stake at the corner of Green Avenue and Nichols Streets and running thence with Green Avenue S 28 W. 1.73 Chains to a stake corner of lot No. 8; thence with line of Lot last mentioned S. $76\frac{3}{4}$ E. 1.25 chains to a stake on line of Lot No. 2; thence with line of Lot last mentioned N. 28 E. 1.90 chains to a stake on Nichols Street; thence with said Street N. $76\frac{3}{4}$ W. 1.25 chains to beginning corner, more particularly described as Lot No. 1 of the subdivision of the Martha Sloan Homestead in Plat made by J. K. Dickenson, D. S. on January 6, 1891."
