

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Lucille Collins of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, Lucille Collins, the said, my certain note or obligation, bearing date the 21st day of December 1928

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of One Thousand (\$1,000.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 21st day of December A. D. 1928

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I, Lucille Collins, the said, shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of January 1929

and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Fifteen + 83/100 (\$15.83) Dollars, (Ten (\$10.00) Dollars, being the regular monthly installment payable on the Ten Shares of Stock, and Five + 83/100 (\$5.83) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of

Fourteen + 67/100 (\$14.67) Dollars, (Four + 67/100 (\$4.67) Dollars, being the regular monthly payment on said stock and Four + 67/100 (\$4.67) Dollars, being the monthly interest on balance due); for the next twenty months the sum of

Thirteen + 50/100 (\$13.50) Dollars, (Three + 50/100 (\$3.50) Dollars, being the regular monthly payment on said stock and Three + 50/100 (\$3.50) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of

Twelve + 33/100 (\$12.33) Dollars, (Two + 33/100 (\$2.33) Dollars, being the regular monthly payment on said shares of stock and Two + 33/100 (\$2.33) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of

Eleven + 17/100 (\$11.17) Dollars, (One + 17/100 (\$1.17) Dollars, being the regular monthly payment on said shares of stock and One + 17/100 (\$1.17) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Ten shares of stock and the certificate thereof of the amount at such time paid share of me to be credited as a payment upon the advance or loan made me the said Lucille Collins

and shall pay or cause to be paid all taxes which may be duly imposed upon, or charged against me the said Lucille Collins in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the conditions thereunder written, reference being thereunto had will more fully appear.

NOW KNOW ALL MEN, that I, Lucille Collins, the said, in consideration of the sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Lucille Collins

in and well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All that certain lot of land situate in Greenville Township, County and State aforesaid, near Judson Mills, and being known as Lots No. 68 on a plat of the Pride & Patton Land Company, recorded in Plat Book E, at Page 249, R. M. C. Office for Greenville County. Said lot has the following metes and bounds:

Beginning at an iron pin on the south side of Goodrich Street, which pin is 203.8 feet N. 64-49 W. from the intersection of Goodrich Street and Valley Street, and at the corner of Lot No. 69 and thence running with Goodrich Street N. 64-49 W. 76.4 feet to an iron pin at the corner of Lot No. 69, thence in a south westerly direction with the line of Lot No. 67 135.1 feet to an iron pin at the corner of Lots Nos. 62, 67 and 68; thence S. 59-23 E. 75.35 feet to an iron pin at the joint corner of Lots Nos. 61, 68 and 69; thence in a northeasterly direction with the line of Lot No. 69- 142.4 feet to the beginning corner. Being the same lot conveyed to me Lucille Collins, by Frank C. Moore on March 27, 1926, by deed recorded in Vol. 106, at Page 472, R. M. C. Office for said Greenville County.
