of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting: *L. Henrietta M. Bee*

WHEREAS, *L. Henrietta M. Bee*, the said *Henrietta M. Bee* in and by *my* certain note or obligation, bearing date the *4th* day of *February* 192*9*

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Forty Two Hundred (\$4,200.00)* Dollars, with interest thereon at the rate of *seven* per centum per annum, payable monthly, from the *4th* day of *February* A. D. 192*9*

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that *L. Henrietta M. Bee* the said *Henrietta M. Bee* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *March* 192*9*

and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Sixty Six + 50/100 (\$66.50)* Dollars, (*\$42.00* Dollars, being the regular monthly installment payable on the *Forty two* Shares of Stock, and *Twenty four + 50/100 (\$24.50)* Dollars, being the monthly interest on the advance of loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Sixty One + 100/100 (\$61.00)* Dollars, (*\$42.00* Dollars, being the regular monthly payment on said stock and *Nineteen + 60/100 (\$19.60)* Dollars, being the monthly interest on balance due);

for the next twenty months the sum of *Fifty six + 70/100 (\$56.70)* Dollars, (*\$42.00* Dollars, being the regular monthly payment on said stock and *Fourteen + 70/100 (\$14.70)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Fifty one + 80/100 (\$51.80)* Dollars, (*\$42.00* Dollars, being the regular monthly payment on said shares of stock and *Nine + 80/100 (\$9.80)* Dollars, being the monthly interest on balance due); for the next twenty months pay

the sum of *Forty six + 90/100 (\$46.90)* Dollars, (*\$42.00* Dollars, being the regular monthly payment on said shares of stock and *Four + 90/100 (\$4.90)* Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month and shall thereafter be paid to the Company the said *42* shares of stock and the certificate thereof, the amount at such time paid shares by *Henrietta M. Bee* shall be credited as a payment upon the advance or loan made *me*, the said *Henrietta M. Bee* and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against *me* the said *Henrietta M. Bee*

said note or obligation, and the condition thereupon written, reference being thereunto had will more fully appear. NOW, KNOW ALL MEN That *Henrietta M. Bee* the said *Henrietta M. Bee* in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *me* the said *Henrietta M. Bee*

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situate in the County of Greenville, State of South Carolina, and described as follows:

In Greenville Township, Greenville City, Beginning at a stake on the East side of Wilton, St 200 feet South from the south east corner of Wilton and Croft Streets, running thence with a 1/2 foot alley S. 83-13 E. 150 feet to a pin; thence N. 1-41 E. 66 2/3 feet to a pin; thence N. 83-13 W. 150 feet to a pin on Wilton Street; thence with Wilton Street S. 1-41 W. 66 2/3 feet to the point of beginning. This being the same land conveyed to me, Henrietta M. Bee, by E. Sumner, Master, January 29, 1929, deed to be recorded.
