WHEREAS, *J. P. Barr*, the said *J. P. Barr* in and by *my* certain note or obligation, bearing date the *12th* day of *February* 192*9*

adv indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Four Thousand (\$4,000.00)* Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly from the *12th* day of *February* A. D. 192*9* according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

J. P. Barr the said *J. P. Barr* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *March*

192*9*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Sixty-three + 33/100 (\$63.33)* Dollars, (*\$40.00* Dollars,

being the regular monthly installment payable on the *forty* Shares of Stock and *Twenty-three + 33/100 (\$23.33)* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of

Fifty-eight + 67/100 (\$58.67) Dollars, (*\$40.00* Dollars, being the regular monthly payment on said stock and *Eighteen + 67/100 (\$18.67)* Dollars, being the monthly interest on balance due);

for the next twenty months the sum of *Fifty-four (\$54.00)* Dollars, (*\$40.00* Dollars, being the regular monthly payment on said stock and *Fourteen (\$14.00)* Dollars,

Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Forty-three + 33/100 (\$43.33)* Dollars, (*\$40.00* Dollars,

Barr* in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In Greenville Township, being known and designated as Lot No. 2 as shown on a plat of the N. J. Martin property, recorded in Plat Book N. Page 139, and having the following metes and bounds, according to said plat:
Beginning at an iron pin on the southeast side of Clarendon Avenue at a point 80 feet from the northeast corner of a 10-foot alley and runs thence S 39-36 E. 215 feet to an iron pin; thence N. 58-00 E 64.7 feet to J. P. thence N. 34-22 W. 230.1 feet to an iron pin on Clarendon Avenue; thence with said Clarendon Avenue S. 46-10 W. 80 feet to the beginning corner, and being the same land conveyed to J. P.
