WHEREAS, *I*, the said *Julia R. Huff*

in and by *I* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Fifteen Hundred (\$1500.00)* Dollars,

Huff* in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

*being known and designated as part of lots no. 102 and 103, as shown on plat of property of Mountain View Land Co. which plat is recorded in the office of the R.M.C. for Greenville County in plat book A at pages 396 and 397, being described as follows: Beginning at a stake on the Northside of Martin Street at a point 74 feet from the corner of Martin and Chandler Streets as shown on said plat, running thence N. 11 1/2° E. 100 feet to a point on the line of lot No. 101, thence with line of lot No. 101, S. 89 1/2° E. 74 feet to a stake on a ten foot alley, thence along the west side of said alley S. 11 1/2° E. 100 feet to a stake on Martin Street, thence along Martin Street N. 89 1/2° E. 74 feet to the point of beginning, being one-half of lots no. 102 and 103 as shown on said plat.*
