to warrant and forever defend, all and singular the said premises unto the said Blue Ridge Lumber Company, its successors Heirs and Assigns, from and against myself and my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same, or any part thereof.

And the said Mortgagor... agree... to insure the house and buildings on said lot in a sum not less than Forty Seven Hundred Fifty and no/100 Dollars (in a company or companies satisfactory to the mortgagee...), and keep the same insured from loss or damage by fire, and assign the policy of insurance to said mortgagee..., and that in the event that the mortgagor... shall at any time fail to do so, then the said mortgagee... may cause the same to be insured in _____ name and reimburse _____

for the premium and expenses of such insurance under this mortgage, with interest.

And if at any time any part of said debt, or interest thereon be past due and unpaid... hereby assigns the rents and profits of the above described premises to said mortgagee..., or...
