WHEREAS, I, Emma Lue Neaton, the said Emma Lue Neaton,
in and by my certain Promissory note, in writing, of
even date with these presents, am well and truly indebted to

Lyda D. Neal
in the full and just sum of Seven Hundred Fifty (\$750.00)
Dollars, to be paid One year from date with privilege of an-
ticipating payment

with interest thereon, from 13th June 1933 at the rate of eight per cent. per annum to be
computed and paid semi-annually

until paid in full all interest not paid when due at interest at the same rate as principal; and if any portion of prin-
cipal or interest be at any time part due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder

hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten percent of amount due besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said Emma Lue Neaton

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do
grant, bargain, sell and release unto the said Lyda D. Neal

Lyda D. Neal, her heirs and assigns, all that cer-
tain piece, parcel or lot of lands in Greenville
Township, Greenville County, State of South Caro-
lina, in the subdivision known as Saw Sausi
Annes, being designated as lot no. 9 as shown
on a plat recorded in the R. M. C. Office for
Greenville County in Plat Book "C" at Page 29,
and having the following meter and bounds
to-wit:

Beginning at a stake on Perry Road at the joint
corner of plots nos. 8 and 9 and running thence
along the said joint line S. 42-20 E. 157.75 feet to
a stake on a ten foot alley; thence along the line
of said alley S. 42-40 W. 150 feet to a stake at joint
corner of lots nos. 9 and 10; thence along said joint
line N. 42-20 W. 157.5 feet to a stake on Perry Road;
thence along Perry Road N. 42-40 E. 50 feet to the be-
ginning corner, this being the same land conveyed
to said Emma Lue Neaton by Frances B. Endel, Dec-
ember, 12, 1929, by deed to be recorded.
