In the City of Greenville at the intersection of Hartsell and Maple Avenues and having a frontage on the North side of Maple Avenue of 35 feet and running back parallel along Hartsell Avenue a depth of 70 feet and known and designated as a part of lot No. 11 by a survey made by C. M. Furman.

Also all that other lot of land in the City, County and State aforesaid on the East side of Hartsell Avenue: Beginning at a pin on East side of Hartsell Avenue at a point 70 feet North of intersection of Hartsell and Maple Avenues and running thence with East side of Hartsell Avenue in a northerly direction 70 feet; thence with line of lot No. 10, in an easterly direction 35 feet to Glenn property; thence with Glenn property and in a line parallel with Hartsell Avenue in a southerly direction 70 feet to pin; thence west in line parallel with Maple Avenue 35 feet to beginning, and being known as a portion of lot No. 11.
