all that tract or lot of land in Township, Greenville County, State of South Carolina.

All those certain lots or parcels of land situate lying and being just without the corporate limits of the city of Greenville, S.C. being known and designated as follows:

1. Lot No. 7 in Block C. of the O.P. Mills property as shown on plat recorded in the R.M.C. office for Greenville County in Plat Book C, Page 284.
2. Lot No. 10 in Block D of the O.P. Mills property as shown on Plat recorded in the R.M.C. Office for Greenville County in Plat Book F, page 299.
3. Lot No. 13 in Block O. of the O.P. Mills property fronting on Kim Street as shown on plat of property recorded in the R.M.C. Office for Greenville County in Plat Book F, page 299.
