SEND GREETING:

WHEREAS, I, the said *Leila J. Barton*, in and by *2227* certain promissory note in writing, of even date with these presents, well and truly indebted to

*C. P. Phillips* in the full and just sum of *One Thousand Dollars*, to be paid *One year from date* *January 16, 1928*

with interest thereon, from *date* *January 16, 1928* at the rate of *8* per cent. per annum to be computed and paid.

until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

*50 dollars* besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage) as in and by the said note, reference being thereto had as will more fully appear.

NOW, KNOW ALL MEN, That *I, Leila J. Barton*, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

*C. P. Phillips*, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *Leila J. Barton*, the said

*Leila J. Barton* in hand well and truly paid by the said *C. P. Phillips*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released and by these Presents do grant, bargain, sell and release unto the said *C. P. Phillips* #7148

All that certain lot or piece parcel of land lying and being in the state of South Carolina in the county of Greenville in which Springes Township being a portion of the said tract division of E. M. Shartan, near Greenville in the state and county aforesaid, and having the following mites and bounds: Beginning at a stake in the National Highway corner late No. 23 and 24 and running thence along said Highway N. 81-45 E. 50 feet to a stake corner late 25 & 26, thence N. 8-15 E. in line for lots 25 & 26, 178 feet and 6 inches to a stake corner on the N. 8-15 E. way to a stake corner late 23 & 24, thence S. 8-15 E. in line late 23 & 24, 189 feet and 8 inches to a stake at the beginning corner. (This deed is for lots 24 & 25 as shown by a plat of same made by R. E. Dalton, Engineer during the month of June 1917 and recorded in plat book 6 at page 50 R. M. C. office). Also beginning at a stake on the National Highway corner late 25 & 26 and running thence along said Highway N. 81-45 E. 50 feet to a stake in corner late 27 & 28, thence N. 8-15 E. 199 feet and 6 inches to a stake corner on the line of N. 8-15 E. thence west along said line 54 feet and 6 inches to a stake corner late 25, thence from said corner 178 feet and 6 inches to a stake at the beginning corner. (As shown by plat recorded in R. M. C. office for Greenville County plat book 6 page 50. The property herein conveyed is the same land heretofore conveyed to E. M. Shartan by deed of E. M. Shartan dated Feb 26, 1923 recorded in vol 89 page 221 R. M. C. office for Greenville County. Also all that certain lot (parcel or piece) of land lying and being in the state and county aforesaid and in the city of Greenville just south of Hampton Ave and west of Kelly Ave. or Bramlett road and having the following mites and bounds.)

Beginning at an iron pin at the northwest corner of lot 2 E. O. Couch which iron pin is one hundred and fifty feet from southern side of Hampton Ave and running thence S. 18-45 E. 181 feet to a stake, thence S. 81-15 E. 261 feet to a stake, thence N. 10-55 E. 75 feet more or less to a stake, thence N. 81-15 E. 30 feet to a stake, thence N. 10-25 E. approximately 69 feet to stake, thence N. 74-00 E. approximately 211 1/2 feet to beginning. Together with the right to the grantee his heirs and assigns in common with the grantors their heirs and assigns to use a private alley 30 feet in width and 150 feet in length extending from Kelly Avenue to Bramlett road over the southern side of the property retained by the grantors and along a portion of the southern side of the above described lot also a fifteen foot private alley along and over the property of the grantors which ally runs along the southern side of the above described property.
