of Greenville, State and County aforesaid and
having the following lines and boundaries:
Beginning at a point on the north side of
Webster Street 211, 1 feet from the intersection
of Oakland Avenue and Webster Street and
turning thence South 70° E. 131.1 feet with line
of Webster Street; thence North 20.0° E. 54.6 feet
to a vent pipe; thence North 45.31° E. 3.2 feet;
