WHEREAS, Lizzie Lee White Millie the said Lizzie Lee White Millie SEND GREETING:

in and by my certain Note or obligation bearing even date herewith, stand indebted unto THE PRUDENTIAL INSURANCE COMPANY OF AMERICA in the full and just principal sum of Forty eight Hundred and no/100 Dollars (\$4,800.00) to be paid in \_\_\_\_\_ years from date, at the dates and in the amounts as follows, namely:

with interest thereon from date hereof at the rate set forth in the note aforesaid, the principal of said note together with interest being due and payable in monthly installments as follows:

Beginning on the first day of October, 1941, and on the first day of each month thereafter the sum of thirty-one and 68/100 (\$31.68) Dollars and the balance of said principal sum due and payable on the first day of September, 1946. The aforesaid monthly payments of thirty-one and 68/100 (\$31.68) Dollars each are to be applied first to interest at the rate as aforesaid on the principal sum of Forty eight Hundred and no/100 (\$4,800.00) Dollars, or so much as shall from time to time remain unpaid, and the balance of each monthly instalment shall be applied on account of principal.

B. Martin property made by R. C. Dalton, Engineer, February, 1933, recorded in the P. M. Co. Office for Greenville County, S.
