Agreement at the redemption rate or rates, with accrued interest to the day or days designated for redemption, and the holders thereof shall look for payment solely to the amount thus deposited for both principal and interest, provided that any funds so deposited by the Company which have not been demanded by the bondholders for a period of one year from the maturity date of this bond issue, or from the date the last bonds are called for redemption, shall be released from this obligation, and the Company shall have the right to use said funds for other corporate purposes.
