with interest thereon from date

at the rate of Seven per centum per annum, to be computed and paid

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest shall at any time pass due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity, it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

M. C. Office for Greenville County in Plat Book "H" at page 132-136, and having according to said plat, the following courses and distances, to wit:-

Beginning at an iron pin 400 feet south of the intersection of North Main Street and West Avondale Drive, joint corner of lots Nos. 9 and 10 and running thence along the joint line of said lots N. 74-40 W. 197.3 feet to an iron pin in the line of an alley; thence along the Eastern side of said alley S. 15-20 W. 100 feet to an iron pin near joint corner of lots Nos. 8 and 9; thence along the joint line of said lots, S. 74-40 E. 197.3 feet to an iron pin in the line of North Main Street; thence along the Western side of North Main Street, N. 15-20 E. 100 feet to an iron pin, the point of beginning.
