TO WHOM ALL THESE PRESENTS MAY CONCERN:

Whereas, the said Judson Mill's Store Company,
in and by John C. Cleveland certain note in writing, of even date with these presents,
well and truly indebted to Judson Mill's Store Company,
in the full and just sum of \$16,000.00,
with interest thereon from July one of 1932,
at the rate of 10 per centum per annum, to be computed and paid semi-annually,
until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to
become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should
be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection
of his interests to place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either
of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mort-
gage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, that John C. Cleveland, the said Judson Mill's Store Company,
in consideration of the said debt and sum of money
aforesaid, and for the better securing the payment thereof to the said Judson Mill's Store Company,
according to the terms of the said note, and also in consideration to the further sum of Three Dollars, to
the said John C. Cleveland,
in hand well and truly paid by the said Judson Mill's Store Company, at and before signing of these Presents, the receipt whereof is hereby acknowl-
edged, have granted, bargained, sold and released and by the Presents do grant, bargain, sell and release unto the said

Judson Mill's Store Company,
all that certain piece, parcel or lot of land situate, lying
and being in Ward One of the City of Greenville, County of
Greenville, South Carolina, on the West side of North Main
Street, and having, according to a plat thereof prepared by
L. M. Turner, Jr., Engineer, September 10, 1923, the following
metes and bounds, to wit;

Beginning at an iron pin on the West side of North Main
Street, said pin being four and one-half inches South of the
Northern line of a thirteen inch brick wall, and being 235
feet South from College Street, and running thence N. 69°
28' W. 130 feet to an iron pin on the East side of a 10 foot
alley, thence along said alley, N. 20° 00' E. 20 feet to the center
of a seventeen inch brick wall, thence along the center of said
wall, S. 69° 28' E. 130 feet to an iron pin on the West side
of North Main Street, thence along said street, S. 20° 00' W.
20 feet to the beginning corner.
