at the rate of 6 percentum per annum, to be computed and paid semi-annually  
until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to  
become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should  
be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed fit by the holder thereof necessary for the protection  
of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either  
of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mort-

All that certain piece, parcel or lot of land on the north side of Lindal Avenue in the City of Greenville, County of Greenville, State of South Carolina known and designated as Lot no. 8 in a plat of the property of Mr. J. H. Lindal, which plat is recorded in the R. P. M. L. Office for Greenville County, S. C., in Plat Book "B," at page 347, and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the North side of Lindal Avenue which iron pin is 136.7 feet West of the Northwest corner of the intersection of Lindal Avenue and Jones Avenue and running thence N. 0-35 E. along the line of Lot no. 7, 175 feet to an iron pin in the line of Lot no. 5, on the above described plat; thence N. 88-25-20. 69 feet to an iron pin, joint rear corner of Lots 8 and 9; thence along the line of Lot no. 9 S. 0-35-20. 175 feet to an iron pin on the North side of Lindal Avenue; thence along the North side of Lindal Avenue S. 88-25-20. 69 feet to the point of beginning, being the same lot conveyed to Mrs. Elizabeth F.
