

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises unto the said Citizens Building and Loan Association of Greer, Greenville County, South Carolina, its successors and assigns forever. AND we the said C. E. Taylor and W. J. Taylor do hereby bind Ourselves and our Heirs, Executors and Administrators, to warrant and forever defend all and singular the said premises unto the said Citizens Building and Loan Association of Greenville County, South Carolina its successors and assigns, from and against us and our Heirs, Executors, Administrators and Assigns, and all persons whomsoever lawfully claiming or to claim the same, or any part thereof.

Provided always Nevertheless, and it is the true intent and meaning of the parties to these Presents, that if we the said mortgagor shall well and truly pay, or cause to be paid, unto the said Citizens Building and Loan Association of Greer, Greenville County, South Carolina, its certain Attorney, successors or assigns, the said debt or sum of money aforesaid with interest thereon, if any shall be due, according to the true intent and meaning of the said Bond and Condition thereunder written, then this deed of bargain and sale shall cease, determine and be utterly null and void; otherwise, it shall remain in full force and virtue. And it is agreed by and between the said parties that the said mortgagor S Heirs, Executors or Administrators, shall and will insure the House and Buildings on said lot in the sum of not less than \$ 500.00

and keep the same insured from loss or damage, by fire, and assign the Policy of Insurance of the said CITIZENS BUILDING AND LOAN ASSOCIATION of Greer, Greenville County, South Carolina, and that in case They shall at any time neglect or fail to do so, then the said CITIZENS BUILDING AND LOAN ASSOCIATION of Greer, Greenville County, South Carolina, may cause the same to be insured in its own name, and reimburse itself for the premium and expenses of such insurance under this mortgage.

AND IT IS AGREED by and between the said parties, that in the case of default of payment under any of the conditions of the said Bond, for the space of three consecutive months, it shall be lawful for the said Citizens Building and Loan Association of Greenville County, South Carolina, to begin legal proceedings, or at its option after three weeks publication in one of the newspapers of the city of Greer, to sell the property hereby mortgaged at public auction, and to apply the proceeds of sale to the extinguishment of the debt under this mortgage, and the payment of all costs and expenses, including Attorney's fees, incurred by such sale, and the Bond intended to be secured thereby, returning the overplus, if any, to the said mortgagor unless the same shall be claimed by a judgment or other mortgage creditor of the said mortgagor and for the purpose of such sale, the said mortgagor hereby appoints and constitutes the President of the said Citizens Building and Loan Association of Greer, Greenville County, South Carolina, and his successors in office, or assigns of said Corporations, or its successors their attorney or attorneys for them and in their name, to execute and deliver proper titles to the purchaser or purchasers for the premises sold.

This power of attorney to remain in full force and to be irrevocable, either by us or our Heirs, Executors and Administrators, until the debt above mentioned shall have been discharged.

And it is further agreed, by and between the said parties, that the mortgagor shall hold and enjoy the said premises, until default of payment shall be made.
