SEND GREETINGS:

WHEREAS, I, the said *Sarah W. West*

am and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of

*Eight hundred no/100* Dollars,

to be paid on or before the date when the *41st* Series of the Instalment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full;

and if *I* fail to pay said interest or comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hand of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear.

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

*on the east side of Augusta Road, known as lot no. 3 on plat by R. C. Dalton February 1920: Beginning at an iron pin on Augusta Road, joint corner of lots 2 and 3, and running thence along line of lot no. 2, N. 55-30 E. 213.4 feet to iron pin; thence S. 55-30 E. 80 feet to iron pin on line of R. H. Adams; thence along line of Adams land S. 53-52 W. 212 feet to iron pin on Augusta Road; thence along Augusta Road N. 54-35 W. 86 feet to beginning; less, however, a lot of land fronting eight feet on Augusta Road, conveyed by Sarah W. West to E. C. Case September 10, 1924, deed recorded in book 96, page 56.*
