

AGREEMENT FOR EXTENSION OF LOAN NO. 237273

WHEREAS, There now remains unpaid on a certain note executed and delivered by Edmund Ouzangh, 3rd

The Prudential Insurance Company of America, secured by a Mortgage upon real estate in Greenville County,

South Carolina, dated December 22, 1932, recorded in said County on March 26,
in Volume 123 of Mortgages on Page 284, the sum of
Four Thousand (4,000.00) Dollars, with interest from December 22, 1932 and,

WHEREAS, Title to the mortgaged premises is now vested in Harriet H. McAlister,

subject to said Mortgage, and,
WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said Harriet H. McAlister

hereby agree to pay the principal sum remaining due as aforesaid as follows: The sum of 50.00 to be paid on December 22, 1933, and quarterly payments of 50.00 on the 22nd days of each and every March, June, September and December hereafter during the life of this agreement, and the balance of the principal on the 22nd of December, 1937,

with interest thereon from December 22, 1932, to December 22, 1937, at the rate of Six (6%) per cent. per annum, payable quarter annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:
Privilege is given to make additional payments on the principal sum of the note in sums of 100.00 or multiples thereof on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said Mortgage shall continue a first lien upon said premises, and that said note and Mortgage and all their covenants and conditions shall remain in force except as herein modified.
