

AGREEMENT FOR EXTENSION OF LOAN NO. 2082

WHEREAS, There now remains unpaid on a certain note executed and delivered by A. B. Carter

to The Jefferson Standard Life Insurance Company
The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated October 13, 1919, recorded in said County on November 13, 1919, in Volume 68 of mortgages on Page 83, the sum of Fifty-three Hundred Fifty (\$5350.00) Dollars, with interest from April 13, 1934, and,

WHEREAS, Title to the mortgaged premises is now vested in A. B. Carter

subject to said mortgage, and,
WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said A. B. Carter and Mae C. Carter, his wife,

hereby agree to pay the principal sum remaining due as aforesaid as follows:
One Hundred (\$100.00) on the 13th day of April, 1935 and a like amount on the 13th day of each and every October and April thereafter up to and including April 13, 1944 and the balance of \$3450.00 on October 13, 1944.

with interest thereon from April 13, 1934, to October 13, 1944, at the rate of seven (7%) per cent. per annum, on the 13th day of October and April each year. payable semi-annually, and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
