

AGREEMENT FOR EXTENSION OF LOAN NO. 294 592-2

WHEREAS, There now remains unpaid on a certain note executed and delivered by Helen A White

The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated August 22nd, 1930, recorded in said County on August 23rd, 1930 in Volume 219 of mortgages on Page 5, the sum of Fifty six Hundred (\$5,600.00) Dollars, with interest from August 22nd, 1935, and,

WHEREAS, Title to the mortgaged premises is now vested in Helen A White

subject to said mortgage, and, WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said Helen A. White and J. Warren White

hereby agree to pay the principal sum remaining due as aforesaid as follows: The sum of One Hundred Forty (\$140.00) Dollars to be paid on principal on the 22nd day of November, 1935 and a like amount on the 22nd day of each February, May, August and November thereafter up to and including May 22, 1945, and then the balance remaining on principal to be paid August 22, 1945.

with interest thereon from August 22nd, 1935, to August 22nd, 1945, at the rate of five and one-half per cent. per annum, payable quarterly; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of said note in sums of One Hundred (\$100.00) Dollars or multiples thereof, on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
