M. C. Office for Greenville County, said Lot of land having the following metes and bounds, to-wit:

"Beginning at a stake on the North side of Overbrook Circle at the corner of a 10-foot alley; thence with the line of said alley N. 13-13 E. 170 feet more or less to a stake on corner of lot conveyed by Annie H. Smith to L. W. Bundy by deed dated Sept. 24, 1926, and running thence with the line of that lot S. 69-45 E. 129.9 feet to a stake on the West side of Overbrook Circle; thence with said street S. 11-39 W. 19.9 feet to a stake; thence S. 27-29 W. 49.9 feet to a stake; thence S. 48-17 W. 49.8 feet to a stake; thence S. 84-42 W. 49.9 feet to a stake at the beginning corner.
