KNOW ALL MEN, That first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to economic the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby nowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell and release in fee simple, unto second party, its successors and assigns, the following described lands, to wit:

'All that certain piece, parcel and tract of land, lying and being situate in Austin Township, Greenville County, State of South Carolina, containing Fifty-Six and 09/100 (56.09) acres, according to a plat and survey made by W. J. Riddle, Surveyor, March 29, 1934, and bounded on the North by lands of W. H. Miller and the Old Greenville & Laurens Public Read, on the East by T. L. Garrett and P. C. and C. J. Jones, on the South by P. C. and C.J. Jones and on the West by P. C. and C. J. Jones and W. H.
