well and truly indebted to

in the full and just sum of *One Thousand One Hundred Dollars* Dollars

to be paid as follows: it is agreed by the two above named parties, each
 in the sum of *500* dollars due and payable on the *14th day of October* and
 thereafter at the rate of *12 per cent.* per annum, to be computed and paid *quarterly*
 with interest thereon from the date of payment first and interest to be paid quarterly, and balance to be collectible for
 at the rate of *12 per cent.* per annum, to be computed and paid *quarterly*
 until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past
 due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose
 this mortgage; said note further providing for an attorney's fee of *ten per cent.*
 besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the
 hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured
 under this mortgage); as in and by the said note, reference being thereto had, will more fully appear.

NOW KNOW ALL MEN THAT

I, the said *E. Floyd L. Russell*

in consideration of the said debt and sum of money aforesaid, and for the better

securing the payment thereof to the said

Capital Agency Co., Inc.

according to the terms of said note, and also in consideration of the further sum

of *Three Dollars*, to the said*E. Floyd L. Russell*in hand well and truly paid by the said *Capital Agency Co., Inc.*at and before the signing of these Presents, the receipt whereof
 is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said*Capital Agency Co., Inc.*

all that certain piece, bounded up set of land situate, lying
 and being just outside the *Westgate* Subdivision in Greenville County,
 State of South Carolina, having known and designated as Lot
 number *53* as shown on plat of the property of North Hill
 recorded in the *M.M.C.* office of the *Socorro Society* in plat book
"H" at page *138* and bearing the following dimensions to
 wit:

Beginning at an iron pin on the south side of
 Baldwin Avenue which iron pin is *10* feet from the south
 western corner of the intersection of Baldwin Avenue and
14th Street sticks, then joint corner of *1st* & *5th* and *5th* & *6th*; thence
 running with the front line of said *1st* & *18-19th* E. *1/40* feet
 to an iron pin on the south side of a *10* foot alley; thence
 along the line of said alley *11-11-1/43* E. *1/4* feet to an iron pin;
 thence S. *18-17-11-1/40* feet to an iron pin on the north side of
 Baldwin Avenue; thence along the line of said Avenue S. *11-11-1/2*
 E. *1/4* feet to the joint of beginning.
