at the rate of eight per cent. per annum, to be computed and paid semi-annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of fifty Dollars besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

 All that certain piece, parcel and lot of land in the City of Greenville, in the County of Greenville aforesaid, on the south-west corner of St. John and Main Streets, on which my present residence is located, and having the following dimensions and boundaries: Beginning at the said corner of said streets, and running along St. John street seventy-five feet, more or less, to a stake; thence in a south-westly direction one hundred and fifty-five feet and one-half feet, more or less, to line of Grimes property; thence along Grimes' line, in a south-easterly direction, seventy-six feet, more or less, to stake on Main Street; thence along said street, in a north-easterly direction, one hundred and fifty-eight and one-half feet to the beginning corner.

This lot is a portion of a lot conveyed by Sandy Johnson to Thos. Lewis on Feb. 26th. 1879. see Vol., K.R. at page 600, the said Thos. Lewis having devised the same to his wife Rebecca Lewis and his only child Henry Lewis. I, the said Louisa Gray, am the daughter of said Rebecca Lewis by another marriage. The said Henry Lewis died unmarried, leaving no child nor other brother nor sister. The said Rebecca Lewis died intestate after the said Henry Lewis and I am her sole heir-at-law and distributee.
