AMORTIZATION MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, That

W. D. Richardson,

of Greenville County and State aforesaid, hereinafter called first party, whether one or more, SEND GREETINGS:

WHEREAS, First party is indebted to the Land Bank Commissioner, acting pursuant to Part 3 of the Act of Congress approved May 12, 1933, known as the Emergency Farm Mortgage Act of 1933, hereinafter called second party, as evidenced by a certain promissory note, of even date herewith, for the principal sum of Eighteen hundred and no/100 (\$ 1800.00) Dollars, payable to the order of the second party, together with interest from the date of said note on the principal sum remaining from time to time unpaid, at the rate of five (5%) per centum per annum, the first payment of interest being due and payable on the first day of November, 1935, and thereafter interest being due and payable annually; said principal sum being due and payable in ten (10) equal, successive, annual installments of One hundred eight and no/100 (\$ 180.00) Dollars each, and a final installment of ----- (\$ -----) Dollars, the first installment of said principal being due and payable on the first day of November, 1939, and thereafter the remaining installments of principal being due and payable annually until the entire principal sum and interest are paid in full; all of which and such other terms, conditions, and agreements as are contained in the said note, will more fully appear by reference thereto.

NOW, KNOW ALL MEN, That first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to second party, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell and release in fee simple, unto second party, his successors and assigns, the following described lands, to wit:

All that certain piece, parcel and tract of land, lying and being situate in Fairview Township, Greenville County and State of South Carolina, about 2 miles Southwest of the Town of Simpsonville; on the Nelly Ferry Road, containing one hundred four and twenty-eight hundredths (104.28) acres, according to a survey and plat made by W. J. Riddle, Surveyor, January, 1925, said lands being bounded on the North by the Farmers Bank of Simpsonville and A. G. Huff; on the East by A. G. Huff and S. G. Black; on the South by S. G. Black, Mamie R. Myers and E. L. Martin; and on the West by E. J. Myers and shown by courses and distances on the plat as follows:

Beginning at a stone on the extreme Southwestern corner of said lands of E. L. Martin's property on the Neely Ferry Road, and running thence along said road as a line North 22 degrees East 11 chains 64 links to a stone; thence North 5 degrees 45 minutes East 6 chains 91 links to a stone; thence North 3 degrees 45 minutes East 9 chains 81 links to a stone; thence North 39 degrees 30 minutes East 30 chains 72 links to a stake; thence South 30 degrees East 2 chains 44 links to a stake; thence South 16 degrees 30 minutes East 6 chains to a stake; thence South 50 degrees 30 minutes East 3 chains 50 links to a stake; thence South 42 degrees East 8 chains and 65 links to a stake; thence South 58 degrees 15 minutes West 38 chains 92 links to a hickory; thence North 75 degrees 15 minutes West 14 chains 68 links to the beginning corner.

This is the same tract of land conveyed to W. D. Richardson by Mrs. M. S. Richardson and others, by deed dated January 28, 1925.

Copy of the above described plat is now on file with the Federal Land Bank of Columbia, for itself and as Agent of the Land Bank Commissioner.

This Mortgage is executed to the second party acting for and on behalf of the Federal Farm Mortgage Corporation, pursuant to part 3 of Emergency Farm Mortgage Act of 1933, and the Federal Farm Mortgage Corporation Act, and acts amendatory and supplementary thereto.
