All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situated affixing and being in the State of South Carolina, County of Greenville, and in the City of Greenville, on the west side of Robinson street, and being known and designated as Lot "B" of the property of H. J. Merlin, according to a plat made by Dalton & Hayes, Engineers, and recorded in the R. M. L. office for Greenville County in Plat Book D, at page 205, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of Robinson street, at a point 30 feet from the southwest corner of Robinson street and Kendall street, and running thence south along Robinson street, S. 80° 00' 00" feet to an iron pin, joint corner Lots B and C; thence south west side of said Lot B, 80° 00' 00" feet to an iron pin, in line of Lot B; thence south line of Lot B, N. 80° 00' 00" feet to next iron pin, joint rear corner Lots A and B; thence south the south line of said lots S. 80° 00' 00" feet to last iron pin on Robinson street, the beginning corner.
