All that certain piece, parcel and tract of land, lying and being situate in Fairview Township, Greenville County and State of South Carolina, about 2 miles Southwest of the Town of Simpsonville; on the Nelly Ferry Road, containing one hundred four and twenty-eight hundredths (104.28) acres, according to a survey and plat made by W. J. Riddle, Surveyor, January 1925, anid lands being bounded on the North by the Farmers Bank of Simpsonville and A. G. Huff; on the East by A. G. Huff and S. G. Black; on the South by S. G.
