Beginning at an iron pin on Railroad Street and at the
corner of Lot No. 29, and thence running along Railroad
Street 30 feet to a stake at the corner of Lot No. 27; thence
along the line of Lot No. 27, N. 77-30 W. 77 feet to a stake at
the corner of Lots Nos. 41 and 42; thence along the rear line
of Lot No. 41, S. 10-40 W. 30 feet to a stake at the corner of
