SEND GREETING:

WHEREAS, I, *J. Josh Smith*, the said *person*, in and by my certain promise, in writing, of even date with these presents, am well and truly indebted to *Palmetto Finance Co. Inc.*, in the full and just sum of Two Hundred Fifty (\$250.00) Dollars, to be paid in installments of Twenty (\$20.00) Dollars each on the following dates: January 15, 1935, January 15, 1935, February 1, 1935, February 15, 1935, March 15, 1935, March 15, 1935, April 1, 1935 and the balance of \$110.00 payable on April 5, 1935, with interest thereon, from date at the rate of 7 per cent. per annum to be computed and paid at maturity, *for interest*, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent.* *plus expenses*, besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, *J. Josh Smith*, the said *person*, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *Palmetto Finance Co. Inc.*

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*, the said *J. Josh Smith*, in hand well and truly paid by the said *Palmetto Finance Company, Inc.*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell and release unto the said *Palmetto Finance Company, Inc.*

All those two certain lots or parcels of land situate, lying and being on the South side of Birnie Street in the City of Greenville, South Carolina, and being known and designated as lots nos. 18 and 19 of the Laddson A. Mills property, as shown on plat made by Dalton & Nevey, Engineers, May 1930, recorded in the R.M.C. Office for Greenville County in Plat Book "S" at Page 272, and having according to said plat, the following metes and bounds, to wit:

Beginning at the South east corner of Crook and Birnie Streets and running thence with Birnie Street N. 70-12 E. 74.2 feet to an iron pin, corner of lot no. 17; thence with the line of that lot S. 17-21 E. 88.7 feet to the line of lot no. 20; thence with the line of that lot S. 72-00 W. 74.7 feet to an iron pin in Crook Street; thence with Crook Street N. 17-21 W. 98 feet to the point of beginning.
