Those two certain tracts of land in Highland Township, said County and State, designated as Lots 1 and 3 of the B. S., D. 20, and C. C. Pease property per plat of H. S. Brockman, Dec. 3rd, 1938, and described as follows:

Tract no. 1: Beginning at iron pin in center of Feus Bridge road and runs thence N. 35° E. 20.1705 feet to iron pin and rightwood knot, thence S. 52-08 E. 214.5 feet to stake; thence N. 32-58-20.387.5 feet to stake, 20. C. gone Q. M.; thence S. 37-20.386.5 ft to stake, thence S. 9 E. 129 ft. to poplar SX; thence S. 9.05-20.224 feet to 20. C. SX; thence S. 8-15-20.307.5 ft to poplar SX; thence S. 10-20-20.182 ft to walnut (dead); thence S. 13-30-20.145 ft to stake; thence S. 86.307 ft to 3 poplars on branch; thence S. 88-08 E. 513 ft to stake on bank of branch; thence S. 36-30 E. 841 ft to point in center of said Feus Bridge; thence S. 51 E. 100 feet to slight turn in said road; thence N. 48 E. 500 ft to another bend in road; thence N. 57 E. 100 ft to bend in road; thence S. 68 E. 300 ft to another bend in road; thence N. 76-45 E. 100 ft to iron pin in center of road, the beginning corner, and containing 44.56 acres, more or less. Tract no. 2: Beginning, at a point in the center of Feus Bridge road, and runs thence N. 36-30-20.841 ft to stake on branch; thence N. 88-08-20.072 ft to three poplars on branch, thence N. 820.207 ft. to stake; thence N. 13-30 E. 143 ft to walnut tree (dead); thence N. 10-20 E. 182 ft. to poplar SX; thence N. 8.10 E. 307.5 ft to 20. C. SX; thence N. 9.05 E. 224 ft to poplar SX; thence N. 9-20.124 ft to stake; thence S. 37-20.742 ft. to stake in 20. C. stump hole Q. M.; thence S. 64.10-20.470.7 ft to sweetgum SX on branch; thence S. 24.45 E. 187 ft to sourwood SX; thence S. 13-30 E. 116 ft. to double poplar on branch SX; thence S. 41-00 E. 1030 ft to a point in center of said Feus Bridge Road corner of Tracts 1, 2, 3 and 2 on said plat; thence along center of said Feus Bridge Road N. 50 E. 223 ft to bend in road; thence along said road N. 66 E. 100 ft to another bend in road; thence along said road N. 83.45 E. 108 ft to point in middle of said road on the line of the old Feus Cemetery; thence along the line of the said Cemetery N. 24 W. 210 ft. to stake; thence N. 64.50 E. 66 ft. to stake; thence N. 78.40 E. 932 ft. to stake; thence S. 32 E. 241 ft along the line of said Feus Cemetery to point on the said Cemetery line in center of said Feus Bridge Road; thence N. 84.15 E. 95 ft to slight bend in said road; thence along said road N. 72 E. 100 ft to point in the middle of said road the beginning corner and corner of Tracts 2 and 1, and containing 37.4 acres more or less.

These being the same two tracts deeded to D. 20 and D. Land E. C. Pease by Minnie L. Pease, Executrix of the Will of A. F. Pease, by Deed dated Dec. 10th 1938 and the interests of D. 20 and E. C. Pease conveyed to me by Deed of January 1933 recorded Book 174, page 203, less a lot of three acres heretofore sold by me to Rollins from Tract no. 1.
