SEND GREETING:

WHEREAS, I, T. T. Thompson, the said T. T. Thompson,
in and by my certain promissory note in writing, of
even date with these presents, am well and truly indebted to
Pettigree Thompson and Anna Thompson,
in the full and just sum of One thousand (\$1000.00) Dollars
to be paid five years from date

with interest thereon, from maturity, at the rate of 7 per cent. per annum, to be
computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of
principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the
holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10%

besides all costs and expenses of collection, to be
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said
debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the
the said note, reference being thereunto had, as will more fully appear.

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me

in hand well and truly paid by the said Pettigree Thompson and Anna Thompson,
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents
do grant, bargain, sell and release unto the said Pettigree Thompson and Anna Thompson,

All that certain tract of land situate, lying and being in Butler Township,
Greenville County, South Carolina on the west side of the Woodruff Road and running to
the center of said road, this said tract of land being a portion of the 119 acre tract
which belongs to me, the said tract of land which it is my intention hereby to mortgage
is bounded by the lands of C.K. Watson, Claude Neely Estate, J. E. Summey, and my own
land, the balance of my land which is not covered by this mortgage lies on the East side
of the aforesaid road and runs to and down and along the center of the said highway.

It is understood and agreed that this mortgage is junior to the mortgages in
favor of the Federal Land Bank and the Land Bank Commissioner.
