I, D. F. Williams SEND GREETINGS:

Whereas, I the said D. F. Williams

in and by my certain promissory note in writing, of even date with these presents, am  
well and truly indebted to South Carolina National Bank

in the full and just sum of One Thousand seven hundred and fifty  
and no/100 (\$ 1750 ) Dollars, to be paid

at the rate of fifty and no/100 (\$ 50.00 ) Dollars per  
month, but the entire indebtedness both principal  
and interest to be paid in full three (3) years from  
date, payments to be made on the 1st day of each  
month

with interest thereon from date at the rate of 7 per centum per annum, to be computed and paid

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to  
become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should  
be placed in the hands of an attorney for suit or collection, or before its maturity it should be deemed by the holder thereof necessary for the protection  
of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either  
of said cases the mortgagor promises to pay all costs and expenses including seven cont. of the indebtedness as attorneys' fees, this to be added to the mort-  
gage indebtedness, and to be secured under this mortgage as a part of said debt.

South Carolina National Bank, its successors  
and assigns;

All that piece, parcel, or lot of land in  
Greenville Township, Greenville County, State of  
South Carolina, located about three (3) miles  
from the Greenville County Courthouse on the  
north side of the Farris Bridge Road, and having  
the following metes and bounds to-wit:

Beginning at an iron pin on the north side  
of the said road and running thence N. 9 3/4 E.  
210 feet to an iron pin; thence N. 80 1/4 W. 412 feet  
to an iron pin, corner of lot formerly owned by  
W. E. Huff; thence along the Huff line S. 9 3/4 W. 210  
feet to an iron pin on the Farris Bridge Road;  
thence along the north side of said road S 80 1/4  
E. 412 feet to the beginning corner, containing 2 acres  
more or less and being the same property con-  
veyed to me by R. L. Merch by deed recorded in
