TO WHOM ALL THESE PRESENTS MAY CONCERN:

I, Sadie K. Davis  
Whereas, I the said Sadie K. Davis  
in and by my certain promissory note in writing, of even date with these presents,  
well and truly indebted to David M. Ramsey

in the full and just sum of Two thousand and no/100  
(\$ 2,000.00) Dollars, to be paid Twenty five (\$25.00)

Dollars on the first day of November, 1945 and  
Twenty five (\$25.00) Dollars on the first day of each and  
every month thereafter until paid in full, the  
monthly payments to cover both principal and interest,

with interest thereon from date at the rate of 9% per centum per annum, to be computed and paid  
credited quarterly until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to  
become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should  
be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection  
of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either  
of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mort-  
gage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece parcel or lot of land situate  
lying and being near the corporate limits of the  
City of Greenville, County and State aforesaid,  
near the Laurins Road and on the East side  
of Underwood Avenue, and being known and  
designated as Lot #39 of Glen Grove Park, as  
shown by plat of same prepared by R. E. Walton,  
Eng. in May, 1924, said plat being recorded in  
the R. M. C. Office for Greenville County, in Plat  
Book "F", page 233, having, according to said  
plat the following metes and bounds, to-wit:

Beginning at an iron pin on the East side  
of Underwood Avenue, joint corner of Lots 38 and  
39 and running thence along the East side of  
Underwood Avenue S. 15-48 N. 50 feet to joint corner  
of lots 39 and 40; thence along the joint line of lots
