situate at the northeastern intersection of Third Avenue and Third Street, and designated as lot No. 2, of Block L of a subdivision known as Park Place, plat of which is recorded in the RMC Office for Greenville County in Plat Book A, page 119, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin at the northeastern intersection of Third Avenue and Third Street running thence with a line of Third Avenue in a northerly direction 50 feet to an iron pin, joint corner of lots nos. 2 and 4; thence along the joint line of said lots in an easterly direction 150 feet to an iron pin; thence in a southerly direction in a line parallel with Third Avenue 50 feet to an iron pin on the line of Third Street; thence along the line of Third Street in a westerly direction 150 feet to the point of beginning.
