And the said mortgagor agree to insure the house and buildings on said lot in a sum not less than One Thousand Dollars Dollars, in a company or companies satisfactory to the mortgagee, and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said mortgagee; and that in the event that the mortgagor shall at any time fail to do so, then the said mortgagee may cause the same to be insured in X name and reimburse X for the premium and expense of such insurance under this mortgage, with interest.
