## RELEASEDEED

The Union Trust Company of Maryland has tendered its resignation by instrument filed for record in Book 188, Page 226, in the aforesaid office of Register of Deeds for Trust County, and under the terms of the said Deed of Trust the South Carolina National Bank, Greenville, South Carolina is authorized to carry out the provisions thereof as Remaining Trustee.
