TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, A.E. Sparks, of the City of Greenville, County of Greenville, State of South Carolina, SEND GREETINGS:

WHEREAS I the said A.E. Sparks

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of

Fourteen Hundred, Fifty & no/100 (\$ 1450.00 ) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Thirty & no/100

( \$ 30.00 ) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

On the Southern side of Hamilton Avenue, in Ward 5 of the City of Greenville, being shown as Lot No 20 on plat of property of H.T.Mills recorded in the R.M.C. Office for Greenville County in Plat Book "C" at Page 223, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Hamilton Avenue, at corner of Lot No.19, and running thence with the line of said lot, S. 16-15 W. 142 feet to an iron pin; thence S. 77-45 E. 50 feet 1 1/2 inches to an iron pin, corner of lot no. 21; thence with the line of said lot, N. 16-15 E. 138 feet 6 inches to an iron pin on Hamilton Avenue; thence with the southern side of Hamilton Avenue, N. 73-45 W. 50 feet to the beginning corner; being the same property conveyed to A.E.Sparks by Frances S.
