I, Rosebud L. Finklea, of Greenville, S. C.

SEND GREETINGS:

WHEREAS I, the said Rosebud L. Finklea

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of

FIVE THOUSAND, SEVEN HUNDRED AND NO/100

(\$ 5,700.00) Dollars, with interest at the rate of 6% per centum per annum, to be repaid in installments of

FORTY-SIX AND NO/100

(\$ 46.00) Dollars upon the first

day of each and every calendar month thereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing, for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

and in Greenville Township, near the City of Greenville, known as Lots Nos. 62 and 63 on Map of Lanneau Drive Highlands, made by Dalton & Neves, August, 1937, plat recorded in the R. M. C. office for Greenville County in Plat Book D, pages 288 and 289, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at a stake on the west side of Lanneau Drive at corner of Lot No. 61, and running thence with Lanneau Drive, N. 10-11 E. 50 feet; thence still with Lanneau Drive, N. 8-43 E. 50 feet to a stake at corner of Lot No. 64; thence with line of Lot No. 64, N. 79-49 W. 148.6 feet to stake; thence S. 10-11 W. 100 feet to stake at corner of Lot No. 61; and thence with line of said Lot 61, S. 79-49 E. 150 feet to the beginning corner. Being the same lot conveyed to me by O. K. Schwiers by deed dated June 16th, 1938 and recorded in the R. M. C. office for Greenville County in Vol. 204, page 284."
