Sloanto The Federal Land Bank of Columbia, securing the payment of the principal sum of Forty Six Hundred- (\$4600.00) Dollars, dated the 2nd day of February, 1934, and recorded in the public records for Greenville County, State of South Carolina, in Mortgage Book 249, at page 74, the property hereinafter described; and that for and in consideration of the sum of One -(\$1.00) Dollars, receipt whereof is hereby acknowledged, Federal Farm Mortgage Corporation, the owner and holder of the security instrument hereinafter referred to and of the note thereby secured pursuant to the Act of Congress known as Federal Farm Mortgage Corporation Act (Sec. 1020b, Title 12, U.S.C.), by and through the Federal Land Bank of Columbia, as its Agent and Attorney in fact pursuant to the Act of Congress known as Farm Credit Act of 1935 (Sec. 1016h, Title 12, U. S. C.) does, subject to the conditions hereinafter stated, hereby release and discharge from the lien of that certain security instrument, executed and delivered by William P. Sloan-, to the Land Bank Commissioner, securing the payment of the principal sum of Thirty Nine Hundred Dollars (\$3900.00) dated the 2nd day of February, 1934, and recorded in the public records for Greenville County, State of South Carolina, in Mortgage Book 250, at page 13 the property hereinafter described, to-wit:

Three (3) acres, more or less, lying in the southeast corner of the 109.45 acre tract of the lands described in the instruments referred to above, in Highland Township, Greenville County, South Carolina, being more particularly described according to plat made by H. S. Brockman, Surveyor, October 10, 1933, as follows:

Beginning at the original southeast corner of said lands at a stone in the center of the Jordan Road (Suddeth's corner); thence with Suddeth's line north 43 degrees 40 minutes east 5.16 2/3 chains to an iron pin; thence north 39 degrees 15 minutes west 6.488 chains to an iron pin; thence south 30 degrees 25 minutes west 5.46 chains to an iron pin in the Jordan Road; thence with said road south 39 degrees 15 minutes east 5.227 chains to the point of beginning; all of which will more fully appear by reference to said plat, on file with the Federal Land Bank of Columbia.
