X And the said Mortgagor agree to insure the house and buildings on said lot for a sum not less than Dollars (in a company or companies satisfactory to the mortgagee); and keep the same insured from loss or damage by fire, and assign the policy of insurance to said Mortgagee, and that in the event that the mortgagor shall at any time fail to do so, then the said mortgagee may cause the same to be insured in its own name and reimburse for the premium and expenses of such insurance under this mortgage, with interest.
