Whereas, I the said J. C. Davis

in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to R. K. Taylor

in the full and just sum of Thirty-One Hundred & No/100 (\$3,100.00) Dollars, to be paid sixty (60) days after date

with interest thereon ~~xxx~~ after maturity at the rate of six per centum per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All those certain pieces, parcels or lots of land situate, lying and being on the Southwest side of Kim Street, near the City of Greenville, in the County of Greenville, State of South Carolina, known and designated as Lots Nos. 20 and 21, of Block B, on revised plat of Grove Park, made by W. J. Riddle, April, 1939, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book J, at pages 68 and 69, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Kim Street, joint corner of Lots Nos. 19 and 20, and running thence with the line of Lot No. 19, S. 25-00 W. 135.9 feet to an iron pin; thence in a Westerly direction 55 feet to an iron pin, joint rear corner of Lots Nos. 21 and 22; thence with the line of Lot No. 22, N. 27-30 E. 127 feet to an iron pin on the Southwest side of Kim Street; thence with the Southwest side of Kim Street in an easterly direction 51 feet to the beginning corner.
