Beginning in the center of a culvert over a branch of Brushy Creek on the South side of Dunham Bridge Road, and running thence with the meanders of the branch in a southerly direction 348 feet, more or less, to a black gum; thence in a southwesterly direction 80 feet, more or less, to an iron pin, corner of property of H. W. and Leona Bollick; thence with the line of said property S. 72 E. 476 feet to an iron pin in line of property of Wilmington Savings & Trust Company; thence with the line of said property N. 22 1/2 E. 441 feet to an iron pin on Dunham Bridge Road; thence with the southern side of Dunham Bridge Road in a northwesterly direction 660 feet, more or less, to the beginning corner; being a portion of the property conveyed to J.
