TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, I. D. Ward, of Taylors, S. C.

SEND GREETINGS:

WHEREAS I, the said I. D. Ward

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

ONE THOUSAND, THREE HUNDRED & NO/100

(\$ 1,300.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of THIRTEEN AND NO/100 Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal, note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum of the holder's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said I. D. Ward

in consideration of the said debt and sum of money aforesaid and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

the said I. D. Ward

in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Chick Springs Township, on the north side of the Super Highway, about 2 1/2 miles west of Greer, and being known and designated as Lots Nos. 7 and 8, of the property of Tandy Walker Dill Estate, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book L, at page 31, and being more particularly described as follows, to-wit:

"BEGINNING at an iron pin on the north side of the Super Highway at the joint corner of Lots 6 and 7, and running thence along the line of said Super Highway, N. 68 E. 100 feet to an iron pin, joint corner of Lots Nos. 8 and 9; thence along the joint line of said lots in a northwesterly direction, 225 feet to an iron pin; thence S. 68 W. 100 feet to an iron pin, joint rear corner of Lots 6 and 7; thence along the joint line of said lots in a southeasterly direction, 225 feet to the beginning corner, Being the same lots conveyed to me by J. Earle Dill, et al., by deed dated Nov. 22, 1940 and recorded in the R. M. C. Office for Greenville County in Vol. 230, page 344."
