SEND GREETINGS:

Whereas, I the said W. M. Woods  
in and by my certain promissory note in writing, of even date with these presents, am  
well and truly indebted to Mary A. Hightower

in the full and just sum of Six Hundred Dollars

(\$) Dollars, to be paid Two Hundred Dollars July 18, 1942  
Two Hundred Dollars July 18, 1943 and the balance of Two Hundred Dollars July 18, 1944  
together

with interest thereon from date at the rate of 6 per centum per annum, computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Mary A. Hightower, her heirs and assigns,

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville and in Oaklawn Township, and being described by metes and bounds as follows, to wit:

BEGINNING at a stake on the south line of Old Hundred Road seven hundred eighty-four (784) feet East along said road from the intersection of the said South line of Old Hundred Road to the eastern edge of the pavement on the Augusta Road, and running thence along said South line of Old Hundred Road North 87 deg. 30 min. East one hundred and forty-three (143) feet to a stake; thence South 2 deg. 30 min. East three hundred four and six-tenths (304.6) feet to a stake; thence South 87 deg. 30 min. West one hundred and forty-three (143) feet to a stake; thence North 3 deg. 30 min. West three hundred four and six-tenths (304.6) feet to the place of the beginning.

The lot of parcel of land above described contains one(1) acre, and is designated as Lot #3 on a sketch or plat made by Dalton and Neves, Engineer.
