I, Gladys H. Simmons, of Greenville SEND GREETINGS:

WHEREAS I, the said Gladys H. Simmons

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

EIGHT THOUSAND FIVE HUNDRED & NO/100

(\$ 8,500.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of

SEVENTY-TWO AND NO/100 (\$ 72.00) Dollars upon the first

day of each and every calendar month hereafter in advance until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, Gladys H. Simmons

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Ward 2, of the City of Greenville, on the west side of Broadus Avenue and being known and designated as Lot No. 15, of Block 1, of Boyce addition, as shown on plat thereof, recorded in the R. M. C. Office for Greenville County in Plat Book A, at pages 90 and 91, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Broadus Avenue, at the joint corner of Lots 4 and 5, of Block 1, which point is approximately 385 feet south of the southwest corner of the intersection of North Street and Broadus Avenue, and running thence along the line of Broadus Avenue, S. 15-15 E. 100 feet to an iron pin, joint corner of Lots 5 and 6, of Block 1; thence along the line of Lot No. 6, S. 76-45 W. 220 feet to an iron pin, in line of the property of the Episcopal Church; thence along the line of Church property, N. 15-15 W. 100 feet to an iron pin, joint rear corner of Lots 4 and 5, of Block 1; thence along the joint line of said Lots 4 and 5, N. 76-45 E. 220 feet to an iron pin on Broadus Avenue, the beginning corner.
