from date hereof, until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Dr. J. C. Moore; his heirs and assigns:-
That certain lot of land, with the improvements thereon, situate in the City, Township and County of Greenville, said State, and being Lot No. 1 of the Frances Montgomery property, according to a plat recorded in plat book F at page 225, and thereon delineated as follows:-

Beginning at an iron pin on the west side of North Main Street, joint corner of lots 1 and 2, which point is 83 feet south of the south-western corner of the intersection of North Main Street and Elford Street, and running thence along the joint line of said lots, N. 61-55 W. 100 feet to iron pin on the side of an eight-foot alley; thence along the eastern edge of said alley, S. 19-54 W. 20 feet to iron pin in line of the Browning property; thence S. 61-55 E. 100 feet to iron pin on the west side of North Main Street; thence with the west side of North Main Street, N. 19-54 E. 20 feet to the beginning corner;

Also the right, title and interest in and to a strip of land eight feet wide and twenty feet long, shown on above plat as the southernmost 20 feet of said 8-foot alley, which was heretofore by mutual agreement closed.

This is the same property conveyed to me by deed of the South Carolina National Bank of Charleston, as Trustee, recorded in Vol. 185, page 136.
